Please review the website for full details.

Routing: Seller will make carrier selection based on current rates, reliability, and transit schedules. Should the Purchaser request alternate transportation, he/she thereby assumes all liability for delays and related charges resulting from that carrier selection.

Delays: Seller is not responsible for delays in making delivery or any failure to make delivery due to causes beyond its control including but not limited to acts or regulations of any governmental authority, acts of God, public disorders, fire, work stoppage or slowdown, accident, flood, war, or national emergency.

Claims for Loss or Damage in Transit: Purchaser is responsible for inspection of merchandise on receipt from carrier. Loss or damage in transit should be noted on the freight bill and a claim filed by Purchaser against the carrier. Should the Purchaser find concealed loss or damage, he should immediately contact the carrier and initiate a claim procedure. Loss or damage of product does not alleviate Purchaser of payment terms obligation.

Returns of Merchandise: Purchasers wishing to return goods should contact Seller and request a Return Authorization. Only goods specified on this Return Authorization may be returned. Returned goods must be accompanied by a copy of the original invoice and the Return Authorization number. Unauthorized returns will be returned to Purchaser at their expense. Merchandise received after 10 days from date of invoice will be charged a 20% restocking charge. Merchandise is non-returnable after 30 days from date of invoice. Used or damaged merchandise is not returnable. "Special Order" items are non-returnable. Once manufacturer of "Special Order" goods has proceeded to a point that they cannot be halted by Seller, they are not cancelable by Purchaser.

Freight Charge: Purchaser is responsible for all postage, shipping & handling, or freight charges.
